Alabama Defense Lawyers Association Elects 2023-2026 Officers, District Directors, Young Lawyers Section Chair, and Women in the Law President at Annual Meeting

AUBURN, ALABAMA (JULY 6, 2023) – The Alabama Defense Lawyers Association (ADLA) held its 58TH Annual Membership Meeting and Elections on June 17, 2023, confirming a new slate of Officers and Directors at the close of the business meeting. The Annual Meeting was held at the Sandestin Golf and Beach Resort in Miramar Beach, Florida. Birmingham attorney Jonathan Hooks of Weinberg Wheeler Hudgins Gunn & Dial, LLC has begun his term as President of the ADLA. "I am honored and excited to serve ADLA as its President.
